

He got a PhD of history in 2004 from Nanjing University. His academic interest and studying fields include: international history and relations in Asian-Pacific region. He published articles on journals including *World History, American Studies, Contemporary International Relations* and *International Political Studies*.

His PhD thesis examines the visual iconography of postage stamps and its role in articulating a postcolonial national identity and state-building efforts in India, Pakistan, and Bangladesh. From "None more loyal" to "Love Macao, love China": how religious exhibitions helped transform the identity of Macao's Catholics during and after the resumption of Chinese administration Stephen Morgan history recordings, music, wildlife and all matter of sound. Chandan has worked in museums and archives for over twenty years, managing and developing education and community-led research programmes for diverse audiences.

Rev'd Prof Stephen Morgan has been Rector of the University of Saint Joseph since 2020, having been the Dean of the Faculty of Religious Studies there since 2018. Originally from Wales in the UK, he is an Associate Professor of Theology and Ecclesiastical History. His research interests are in theology, history and religious studies, with particular reference to Macao, China and East Asia. In October 2021, Catholic University of America Press published his John Henry Newman and the Development of Doctrine.

Dr Stephen A. Murphy is Pratapaditya Pal Senior Lecturer in Curating and Museology of Asian Art at SOAS, University of London. Prior to this he was Senior Curator for Southeast Asia at the Asian Civilisations Museum, Singapore. He specializes in the art and archaeology of early Buddhism and Hinduism in Southeast Asia with a focus on Thailand and Laos. His museological focus engages with issues surrounding colonialism and repatriation with a particular focus on Thailand.

Dr Alison Ohta is the Director of the Royal Asiatic Society of Great Britain and Ireland. She completed her doctoral thesis at SOAS, University of London on bindings of the Mamluk period (1250-1516). She has lectured and published widely on the subject and her recent publications include 'Looking inside the Book: Doublures of the Mamluk Period' in *The Making of Islamic Art, Studies in Honour of Sheila Blair and Jonathan Bloom* (2021); 'Mamluk Qur'ans: Splendour and Opulence of the Islamic Book', Proceedings of the Qur'an Symposium, December 2017 (forthcoming); and 'The Hamadan Qur'an of <u>Öljaytü</u>: vestiges of a binding tradition', Studies in Honour of Barbara Brend, *JRAS* (2022).

Dr Kyunghee Pyun is associate professor of art history at the Fashion Institute of Technology, SUNY. Her scholarship focuses on history of collecting, reception of Asian art, diaspora of Asian artists, and Asian American visual culture. She wrote *Fashion, Identity, Power in Modern Asia* (Palgrave Macmillan, 2018) and *Dress History in Korea: Critical Perspectives on Primary Sources* (Bloomsbury, 2023). She co-edited Interpreting Modernism in Korean Art: Fluidity and Fragmentation (Routledge 2021); American Art from Asia: Artistic Praxis and

Biographies

Dr Andrew Amstutz is an Assistant Professor of History at Queens College, CUNY in New York. He teaches courses on South Asian history, museum studies, and public history. He received his PhD in South Asian history from Cornell University. He has published articles in "Comparative Studies of South Asia, Africa and the Middle East" and "South Asia: Journal of South Asian Studies." In 2021, he was a member (fellow) at the Institute for Advanced Study at Princeton.

Prof Sarah Ansari is a historian of South Asia, also known as the Indian subcontinent. Much of her research focuses on the province of Sindh and the mega port-city of Karachi, today found in Pakistan, and explores the issues of religion, migration, identity, citizenship and gender.

Dr Shaila Bhatti is currently an Associate Professor in the Department of Cultural Studies at the National College of Arts, Lahore, Pakistan. Her academic interests span material and visual cultures of South Asia, colonial/postcolonial social and object histories and identities, as well as the politics of cultural representation. She is the author of *Translating Museums: A Counterhistory of South Asian Museology* published by Routledge.

Bhanu Ghalot is a historical researcher and a cultural practitioner. Her research and practice is rooted in the study of difficult histories of South Asia. She is currently heading a project on 1947 Partition for ReReeti Foundation, British Council and Glasgow Museums. As part of the project she has co-curated an immersive digital exhibition titled Un.Divided Identities: Lesser Known Stories of the Partition. She is also conducting workshops on the subject with schools across South Asia.

Sridhar Krishnan is currently in the final year of his PhD at the Department of International Relations (IR), South Asian University. His research interests have coalesced around issues pertaining to cultural politics and IR. He is currently working on how the Partition of 1947 has remained absent from public memory and the manner in which this amnesia manifests itself in curatorial spaces, especially in the Partition Museum in Amritsar, India.

Dr Chandan Mahal is currently the National Learning and Partnership Manager at the British Library for the Unlocking our Sound Heritage, a project with 10 regional Hub partners aimed to digitise and preserve over 300,00 rare and unique recordings that include oral **NOTES**
